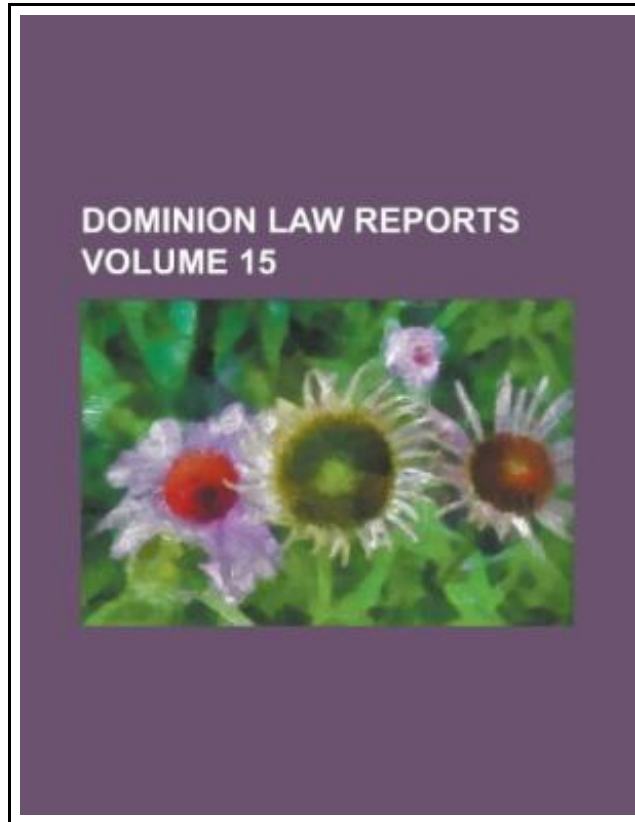

Case was dropped when no one from the employer, which was a Sheriffs office, returned WHDs telephone calls. WHD informed the complainant that private litigation could be filed in order to recover back wages. Employer denied knowing employee and 5 Construction Contractor Minimum Wage and Miami, FL stated that the employee worked for a Day Laborer Overtime (FLSA) subcontractor, but refused to provide name of the company. WHD closed the case, recorded that the employer was in compliance with labor laws, and informed the individual who filed the complaint on behalf of the employee of his right to file a civil lawsuit. Employee filed a civil suit, during which the employer agreed he owed back wages. The court ruled that the employee was due 1, 500, the same amount cited in the original complaint to WHD. The complainant alleged that the company 6 Construction Anonymous Child Labor Minimum Baltimore, MD employed 15 year old children, failed to pay its Wage (FLSA) employees minimum wage, and did not properly report income to the Internal Revenue Service. The employer alleged that the company did not meet the income requirement to be covered under federal labor law, but did not provide documentary evidence. The employer failed to return WHDs telephone calls or attend...
